Old Business

Two complaint forms were read regarding a sewer hookup that is on vacant property and a private driveway that resident wants blacktopped. Clerk will write resident a letter explaining the city will not be blacktopping his driveway. It will also state that in our city ordinance it clearly states that whether you use the sewer or not, you are responsible for paying the quarterly fee.

Some of the residents still have concerns about dogs barking all night and running in town without leashes. LLL is working with residents in the area to get some of the dogs surrendered.

Councilmember Yuhala would like to see residents' property cleaned up and also wants anything close to roadway moved and cleaned up.

New Business

A motion was made to approve the hiring of Cindy Lemm to assist clerk with USDA grants, Sourcewell, and state and federal grants. Pay will be the same as the clerk and treasurer @ \$18.38. **M/S/P (Zobava, Monette)**

Motion was made to approve alternative business to haul sewer shed to the plant **M/S/P (Zobava, Lego)**

A motion was made to approve a \$2,000 Sourcewell Boost grant to purchase a new office door and keyless entry system for that door and the hallway door. Maintenance worker Francis will be able to do the installation. **M/S/P Zobava, Yuhala)**

Resident complained about alleyway behind city hall, 2nd and 3rd Ave East and Pine and Main. Clerk will contact gravel company for estimates on alleyways, 16th, and sewer treatment road while he is here. Council table this until they get an estimate.

Clerk Payment is enrolled in PERA again, a motion to pay in again was made. **M/S/P (Zobava, Monette)**

Larry has got the lawnmower and weed whip running, the fencing at sewer plant is all mended and completed. Sewer shed will be moved soon, a couple sewer issues were reported that were checked on.
