Old Business

- Our sewer maintenance contractor suggests that all residents that are utilizing sewer blankets provided by the city, to start managing them on their own in the future. He stated that they are not necessary, and cause a lot of extra work for the city maintenance employee. They are also a big expense for the city, and take up a lot of much needed limited storage. The council would like the clerk to draft a letter informing residents of the upcoming changes. Clerk will send this out to residents in the 1st quarter sewer bills in 2026. **(M/S/P Zobava, Lego.)**

- Linda has been researching insurance companies to get new quotes. This will be added to our December agenda as she gets more information.

- A Resolution was recommended from Cass County Auditor Treasurer regarding parcel #88-337-0530. Treasurer Knox read the Resolution # 11-10-25. **(ATTACHED TO MINUTES).**
